SPIRIT OF HOPEOUR SPIRIT OF HOPE WAS BORN IN 2013 WITH THE CREATION OF THE PEDIATRIC INTENSIVE CARE UNIT (PICU) AS A REQUIREMENT TO ACHIEVE THE ACCREDITATION OF THE PEDIATRIC HEMATOLOGY-ONCOLOGY UNIT OF SALVATIERRA HOSPITAL. THE CREATION OF THE PICU ALSO ALLOWED THE POSSIBILITY TO PERFORM OPEN-HEART SURGERIES ON CHILDREN AND ADOLESCENTS BECAUSE THE SPECIALIZED AND QUALITY POST-OP CARE WAS NOW AVAILABLE. IN TIME, THE PICU RAISED THE QUALITY OF CARE IN THE WHOLE PEDIATRICS AREA OF SALVATIERRA HOSPITAL.
