Through the Arts in Education Program, we serve a diverse range of schoolsconnecting them to assemblies, workshops, and customized artist-in-residence programs in the visual arts, dance, music, poetry, theatre, creative writing, storytelling, filmmaking, and environmental arts. Seven residency programs took place in FY2021; 4 at schools and 3 virtually. Her Words, a program for Teen Girls at Risk, was virtual for the entire 2020-2021 school year. Our other program for At Risk Teens, Young Artists Mentoring Program, ran virtually from January 2021 to the end of the school year. In February, Morris Arts received funding from the NJACRF for a Teaching Artist Regrant Program. Approximately \$46,600 was regrantd to 29 teaching artists from New Jersey.

Form 990, Part III, Line 4b:

Arts Participation and Advocacy initiatives create and present innovative cultural events that introduce the arts to large and diverse audiences in non-traditional venues and settings. With Covid-19 canceling many of these events in 2020, we were thrilled to be able to bring many of them back in 2021 including Meet Me in Morristown, Giralda Music & Arts Festival, Pumpkin Illuminations and our newest program born out of the pandemic, Morris Arts Fest, which will now be an annual event. In March, 2021, Morris Arts awarded \$6,500 in college scholarships to two area high school students based on artistic excellence. In 2021, Morris Arts advocated locally, regionally and nationally for the arts community and continued to communicate and inform its constituents of local arts events and the importance of the arts.

Form 990, Part III, Line 4c:

Morris Arts continued its strong support of Local Arts organizations with over \$57,000 in regrants with funds from the NEA and the NJSCA. In 2022, the amount of funding available to regrant to local arts organizations will double thanks to an increase in funding from the NEA and NJSCA. Virtual workshops were held during the year in subjects like grant writing and how to make programs accessible to those covered by the Americans with Disabilities Act. These workshops were free to arts organizations.
