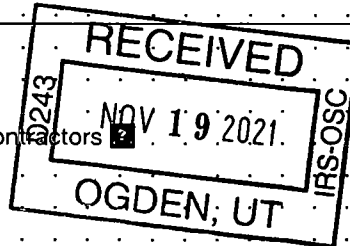



The Italian American Celebration Committee had no fundraising events during this fiscal year because of the Covid lockdown. The organization did not award any scholarships during this fiscal year since no funds were raised. The organization no longer hosts the Columbus Day weekend festival and parade because the city of Hartford no longer recognizes Columbus Day as a public holiday.

Bright Start Vision awarded \$24,000 to students for school fees in Ghana, primarily in the Volta Region. The total number of students supported by Bright Star Vision decreased but more of the remaining students entered university. High school fees are \$300 per year. University fees are \$1,000 per year.

Bright Star Vision used \$4,125 for salaries for teachers and librarians in the Volta Region of Ghana. That was a 10% increase over the previous year. The salaries for teachers and librarians had not increased in many years.

Approximately \$39,500 was sent to Ghana for various repair and construction projects for the school in the village of Dalive and the kindergarten in the town of Sogakope.
