FAUAF PROGRAM SERVICES ACCOMPLISHMENTS IN FY 2020 AND SUPPLEMENTAL INFORMATION MARCH 2020 (FY2019): THE PUBLIC HEALTH AND ECONOMIC SHOCKWAVE OF THE COVID-19 PANDEMIC BEGAN IN MARCH 2020. NEARLY ALL TRAVEL AND MEETING FUNCTIONS WERE SUSPENDED OR CANCELED. FAUAF ALSO MITIGATED EXPENSES TO THE EXTENT POSSIBLE AND STREAMLINING OPERATIONS. FOCUS ON SCIENCE, TECHNOLOGY AND MATHEMATICS (STM) INITIATING NEW PARTNERSHIPS MARCH 2020 (FY2019) FAUAF PURSUED A COMPREHENSIVE ASSESSMENT OF THE STEM LANDSCAPE IN AFGHANISTAN AND THE REGION AND COMPLETED IT DURING FY 2020. JULY 30TH, 2020 (FY2020) FAUAF WAS INVITED TO APPLY FOR A \$286,000 GRANT FROM THE WILLIAM AND FLORA HEWLETT FOUNDATION TO INCREASE TECHNICAL AND VOCATIONAL TRAINING IN AFGHANISTAN THROUGH THE AMERICAN UNIVERSITY OF AFGHANISTAN (AUAF). FAUAF BEGAN LEVERAGING INDIVIDUAL AND CORPORATE PARTNERS TO EXPAND AUAF'S CURRENT OUTREACH IN THE AREA OF STM. WORKING WITH AUAF, FAUAF'S STRATEGIC VISION WAS TO ESTABLISH THE UNIVERSITY AS A CENTER OF EXCELLENCE IN AFGHANISTAN FOR THE DELIVERY OF (STM) TRAINING. THIS PROGRAM IS THE FIRST OF ITS KIND AND DELIVERED TANGIBLE RESULTS IN THE SHORT- AND MEDIUM-TERM FUTURE. THE FOCUS WAS PARTICULARLY ON THE PARTICIPATION OF GIRLS AND WOMEN. THE WEBINAR WAS SCHEDULED FOR DECEMBER 2020. - TO EXPAND ITS DONOR BASE, FAUAF CONDUCTED INNOVATIVE MAILER CAMPAIGNS TO GENERATE REVENUE AND PROGRAMMATIC FUNDING THROUGH SPONSORED PROGRAMS- SPECIFICALLY FEMALE SCHOLARSHIPS IN AFGHANISTAN. - TO SPONSOR NEW COSTS ASSOCIATED WITH ONLINE LEARNING, FAUAF WAS GRANTED \$5K IN PROGRAM SPONSORSHIP FROM RAYTHEON FOR THE PURCHASE OF DATA PACKAGES, HARDWARE KITS, AND COMPUTERS.
