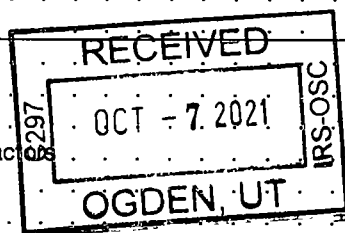

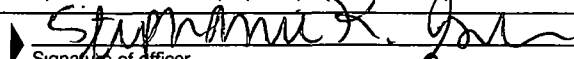

Pt II Ln 17a: The Foundation has a on-going program for requesting donations by attending open houses at the various school buildings to solicit members and donations, by publishing an annual report that includes a letter from the president requesting donations and/or interested new members, and by putting articles in the local newspapers describing the programs they are currently funding at the schools. The interest and dividends they receive each year (50% of support over the past 5 years) is received from monies invested that were received from donation solicitations over the past 25 years. There were annual phone solicitations and mailings to the community requesting donations. Monies raised were invested with the hope of achieving a level of investment income where the annual fund raising would not have to be so time-consuming. The members of the Foundation are all parents, teachers, or of the local public school system. The executive board consists of 15 members who are elected to their positions by the membership. All monies are used to fund "new and innovative" programs at the 4 school buildings within the school district. The Foundation is run by persons dedicated to the success of the local schools and is constantly looking for individuals willing to invest their time and talents in furthering the goals of the Foundation. Membership and fund raising was hindered during the current year due to the schools closing and going virtual due to COVID.
