The Executive Director signs off on all the expenditures and accounting personnel ensure proper reporting is being done. The criteria for application for all of the scholarships are very similar. All of the scholarships have a formal application and specified list of the additional documentation needed for application. The applications are reviewed by the Organization's Board of Trustees and applicants are chosen based on guidelines and eligibility requirements specified when the scholarship was created. All scholarships require either a letter of acceptance or enrollment verification from an accredited school or transcripts from their most recent college semester. Once the scholarship recipients are chosen, the Executive Director authorizes a check to be issued directly to the scholarship recipient. Assistance is given to patients for breast related tests and procedures. The patient is identified by their provider as being uninsured or underinsured and in need of financial assistance. Registration gives them a card outlining the financial guidelines when they recognize that they are private pay patients. The patient affirms that they meet the criteria for financial assistance through our program. She submits a request to the BHF for approval to the program. The Executive Director of BHF reviews and approves the request. The Mammography Manager at Barrett Hospital processes the service through SWMMP.
