However, income from certain activities not directly related to the Foundation's tax-exempt purposes, such as unrelated business income allocated from investment partnerships, is subject to taxation. The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, the Foundation may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. Examples of tax positions include the tax-exempt status of the Foundation, the continued tax-exempt status of bonds issued by the Foundation, and various positions related to the potential sources of unrelated business taxable income. The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. At June 30, 2021 there were no unrecognized tax benefits identified or recorded as liabilities. The Foundation files Forms 990 and 990-T in the U.S. federal jurisdiction and the State of Illinois. With few exceptions, the Foundation is generally no longer subject to examination by the Internal Revenue Service for years before 2018.
