EXPANSION WVCAN has developed and maintained critical partnerships with funders in the state and region to grow the number of WV counties serviced by an accredited CAC from 38 to 44 from 2016 to 2021. 322,827 children, 90 of the states population, now live in a county officially served by a CAC. WVCAN is currently aiding in the expansion of CACs into 4 of the 11 currently unserved counties, bringing our projected total to 95 of children covered in WV.

QUALITY IMPROVEMENT WVCAN helped local CACs evaluate their programs, measure outcomes, and improve the quality of services they provide to children, families, and the communities they serve. Every CAC in WV received an individualized data report that compared their annual data with other CACs in the state and across the nation. WVCAN brought national expertise to WV, conducted on-site and statewide training sessions, worked with local CACs on board development strategic planning, and hosted a virtual statewide conference for professionals in the field. This fiscal year, WVCAN trained 679 individuals at 103 unique offerings provided individualized technical assistance to all 21 CACs in WV.

Awareness WVCAN continued to educate the public and key stakeholders on the prevalence, signs and symptoms of child abuse, recognition and response, and the healing work of child advocacy centers. A marketing audit was conducted for CACs and specialized technical assistance was provided, including the initiation of a website project for both WVCAN and individual CACs websites. Year 2 of the SHINE Campaign featured digital storytelling to reduce the stigma for survivors of child abuse and increase awareness and support. Also, the work of CACs was featured through the Centers of Courage Awards.
