SUCH GOALS INCLUDED INCREASING INDEPENDENCE, PHYSICAL CAPABILITIES, COMMUNICATION SKILLS, AND CHOICE/DECISION MAKING. AT THE HEART OF ALL OF THESE GOALS (AND THE HEART OF THE ORGANIZATION'S DAY SERVICES) WERE FOR PARTICIPANTS TO DEVELOP A SENSE OF SELF-RESPECT AND SELF-WORTH. BECAUSE OF THE COVID-19 PANDEMIC, NO DAY SERVICES WERE PROVIDED DURING 2021.
