Soroptimist International of Kansas City(SIKC) is dedicated to supporting our community, meeting other great women and having a fun time while striving to achieve what is best for women and girls in our community. Our cores values are centered around Gender Equality, Empowerment, Education and Diversity & Fellowship for women and girls. Our mission is to improve the lives of women and girls through our awards and recognition programs, generous grants and hands-on volunteering. In response to the negative impact COVID had on our community in 2020, SIKC through its Foundation established a new one time "Emergency Pandemic Response Awards" program of \$15,000. Requests for the grants were varied and each was worthy, but with limited funds, grants were given to eight local 501c3 organizations whose services and programs met our Soroptimist objectives of improving the lives of women and girls in the Kansas City area. In addition in 2020-2021, our Foundation awarded a total of \$62,295 to 17 local community organizations to support multiple women's programs and causes. Through our Live Your Dreams Award Program, which aids female head of households seeking to expand their opportunities through education, a total of \$6,000 was awarded to 3 women. Applications for these awards were open to all community organizations with programs that further the Soroptimist mission of improving the lives of women and girls in the greater Kansas City area. Because of the COVID environment we experienced in this fiscal year we were limited to fundraiser activities, meetings and donations were negatively impacted. With the COVID environment improving, we anticipate improving our fundraising efforts through strong community support and an increase in our donations as we have experienced in previous years. SIKC has provided services to the community for many decades while the Foundation has been in existence for nearly seventy years. Our membership is made up of women of all ages and ethnic groups, from all walks of life and cultures, in diverse businesses and professions. Our Board members are strong community leaders with professionals who are lawyers, educators, non-profit employees and caring community volunteers.
