IT ALSO SERVES COLLATERALLY AS A FUNDRAISING, NETWORKING AND RESOURCE-SHARING PLATFORM. GEOPARADISE ENCOURAGES AND SUPPORTS INDIGENOUS COMMUNITIES TO PARTICIPATE IN THE ANNUAL "TRIBAL GATHERING" TO SHARE, LEARN, CONNECT WITH ONE ANOTHER TO PROPOSE PROJECT IDEAS THAT COULD BE IMPLEMENTED IN THE VILLAGES TO IMPROVE THE LIVELIHOODS WHILE PRESERVING THEIR CULTURE AND NATURAL HABITAT. TRIBAL GATHERING("TG- OR THE "EVENT") IS THE MAIN PROGRAM AND IS THE STARTING POINT WHERE THE REST OF THE CHARITABLE PROJECTS ARE FORGED WITH THE INDIGENOUS COMMUNITIES. IN A TYPICAL YEAR, THERE IS AN ANNUAL GATHERING OF INDIGENOUS PEOPLE FROM MANY COUNTRIES AND CONTINENTS AND PAID ATTENDEES. THE GATHERING CREATES A HARMONIOUS SPACE FOR INTERCULTURAL EXCHANGE. TRIBAL GATHERING IS AN ANNUAL GATHERING THAT BRINGS TOGETHER APPROXIMATELY 50 TRIBES FROM MORE THAN 40 COUNTRIES. DURING THE GATHERING, TRIBES PEOPLE HOLD WORKSHOPS AND PRESENTATIONS ON VARIOUS ASPECTS OF INDIGENOUS ART AND CULTURE. THERE ARE OTHER WORKSHOPS THROUGHOUT THE EVENT TO EDUCATE THE GENERAL PUBLIC ON ENVIRONMENTAL AND SOCIAL ISSUES, NUTRITION, HEALTH AND SUSTAINABLE DEVELOPMENT. UNFORTUNATELY, THE COVID-19 PANDENIC MADE IT IMPOSSIBLE TO BE ABLE TO HOST THE 2021 EDITION, DUE TO SAFETY AND ECONOMIC CONCERNS. NEVERTHELESS DURING THIS FISCAL YEAR, THE TEAM STILL SPENT A CONSIDERABLE AMOUNT OF HOURS WORKING ON TG RELATED TASKS; WRAPPING UP PENDING TG20 ADMIN TASKS, CLEANING, MAINTENANCE AND INVENTORY OF TG EVENT EQUIPMENT, COMMUNICATION WITH THE INDIGENOUS TRIBES TO FOLLOW UP WITH THEM TO MAKE SURE THEY WERE SAFE THROUGHOUT THE PANDENIC HARDSHIPS, CREATING TG RELATED CONTENT FOR WEBSITES AND SOCIAL MEDIA TO KEEP OUR FOLLOWERS ENGAGED, COMMUNICATIONS WITH OUT PLATFORM THROUGH NEWSLETTERS, PLANNING FOR THE FUTURE TG EDITION, INITIALLY PLANNED FOR 2022 (LATER POSTPONED TO 2023).

EMERGENCY HURRICANE RELIEF IN NICARAGUA & HONDURAS IN EARLY NOVEMBER 2020, HURRICANE ETA-A DEVASTATING CAT 4 HURRICANE - WREAKED HAVOC ACROSS MANY PARTS OF CENTRAL AMERICA. JUST 13 DAYS LATER AN EVEN MORE DESTRUCTIVE CAT 5 HURRICANE, IOTA, WAS SAID TO BE THE STRONGEST HURRICANE TO HIT THE REGION. WE HEARD FROM OUR TRIBAL FRIENDS IN BOTH REGIONS THAT THEY WERE AFFECTED BY THESE HURRICANES CAUSING LANDSLIDES, FLOODS AS WELL AS THE DESTRUCTION OF CORN AND BEANS CROPS, AND SEVERAL HOMES WITH CASUALTIES TO BOTH CHILDREN AND ADULTS. THESE INDIGENOUS COMMUNITIES RELY MOSTLY ON SUBSISTENCE FARMING AND MORE THAN 70% OF THE FAMILIES DO NOT HAVE JOBS OR ANY OTHER SOURCE OF INCOME EXCEPT FOR WHAT THEY GET FROM THE LAND. AFTER RECEIVING THE DISTURBING NEWS WE LAUNCHED AN EMERGENCY RELIEF CAMPAIGN TO GATHER HELP FROM OUR PLATFORM. DURING DECEMBER THROUGH EARLY MARCH WE RAISED FUNDS FROM 137 SUPPORTERS. GEOPARADISE ALSO CONTRIBUTED TO THE DONATION FUNDS AND COVERED OTHER NECESSARY COSTS: ONLINE ADVERTISING, PROMO VIDEOS, FILMING/EDITING FEES, BANK FEES AND CAMPAIGN MANAGEMENT. OUR MAIN GOAL WAS TO PROVIDE NUTRITIONAL SUPPORT TO AS MANY FAMILIES AS POSSIBLE.

WATER AND HEALTH IN RIO CONGO, DARIEN-PHASE 1 AT THE END OF MARCH WE WERE CONTACTED BY A FORMER TRIBAL GATHERING COLLABORATOR FROM THE RED CROSS TEAM IN PANAMA REGARDING A STARTLING DISCOVERY. WE WERE INFORMED THAT THERE WERE AT LEAST 3 COMMUNITIES WITH 78 HOMES AND NO SUITABLE DRINKING WATER SUPPLY. THEIR SOURCE OF WATER IS DIRTY/UNTREATED AND THEY HAVE BEEN GRAVELY AFFECTED BY PARASITES AND BACTERIA RESULTING IN SICK CHILDREN AND OLDER PEOPLE. DURING PHASE 1 OF THIS PROJECT, 100 FAMILIES RECEIVED A WATER FILTER. A MEDICAL TOUR WAS ORGANIZED TO GATHER HELP FROM SEVERAL GOVERNMENTAL BODIES FOR MEDICAL CARE OF THE WOUNDED AND SICK PEOPLE. GEOPARADISE WAS ABLE TO PROVIDE MEALS, HAND SANITIZER, MASKS AND CLEANING SUPPLIES AND ACCOMODATIONS DURING THE MEDICAL TOUR. THE MEDICAL TOUR PROVIDED ASSISTANCE TO 214 INDIVIDUALS FROM 3 COMMUNITIES.
