Avera St. Benedict Health Center's (Avera St. Benedict) mission is to provide healthcare services to Parkston, Tripp and Lake Andes, South Dakota residents and residents of the surrounding area. Avera St. Benedict is a 501(c)(3) organization affiliated with Avera Health. Avera St. Benedict consists of a 25-bed critical access hospital, a 49-bed nursing home, a 25-bed assisted living center and three provider based clinics. Services offered by Avera St. Benedict include primary care, emergency, general surgery, orthopedic surgery, podiatry surgery, cardiac rehab, pain management, pharmacy, behavioral health, laboratory, imaging, telemedicine, wellness center, speech therapy, physical therapy and occupational therapy. Avera St. Benedict provides acute care and long-term healthcare services. Following is a breakdown of these statistics by facility: Avera St. Benedict Hospital 426 Acute patient discharges 40 Newborn patient discharges 163 Swing bed patient discharges 17,482 Outpatient visits 1,422 Swing-bed patient days 57 Newborn patient days 19,917 Clinic visits Avera Bormann Manor 16,559 Nursing home resident days 41 Long Term Care patient discharges Avera St. Benedict maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges forgone for services and supplies furnished under its charity care policy and equivalent service statistics. The amount of charges foregone, based on established rates, were \$151,534. Avera St. Benedict also provides community benefit health activities at less than or at no cost to support those in the area serviced, see Schedule H. As a member of the Avera Health Network, Avera St. Benedict upholds the vision of the Presentation and Benedictine Sisters to work through collaboration to provide quality, effective health ministry and to improve the healthcare of individuals and our communities through a regionally integrated network or persons and institutions. Avera St. Benedict engages in activities designed to improve the health of individuals and communities in response to a calling to heal the sick, the elderly, and the oppressed. During the COVID pandemic over the last two years, Avera Health and its affiliated entities have stewarded significant funding toward community benefit, from our own resources and from state and federal assistance and relief funds. When the first cases were identified in 2020, we created a 24/7 hotline people could call to inquire about testing, treatment, and later vaccination. This hotline minimized the burden of clinics and helped protect patients and the public by keeping patients from presenting to healthcare facilities in person. Along with the hotline, Avera launched an innovative and specialized program for caring for COVID patients at home, including daily checkins, virtual visits (if needed) and at-home oxygen therapy. Throughout the pandemic this program has supported patients and kept hospitals from becoming overwhelmed. Additionally we launched public awareness campaigns for masking and vaccination that included earned media, paid advertising and digital presence. We set up testing sites and events, including a mass testing event for workers at the local protein plant. The state delegated vaccination efforts to South Dakota's health systems, and our state was recognized nationally for our "shots in arms" efficiency. Avera led efforts to prioritize those at highest risk, including not only elderly and infirm but homeless, congregate living residents and protein plant workers which included a high percentage of immigrants. We participated in national research for COVID therapies including convalescent plasma, monoclonal antibodies and antiviral medications. We worked with local and state officials to inform the public at regular press conferences and expanded bed capacity by reallocating resources across all hospitals in our system. Avera partnered with other health facilities and systems to ensure capacity for the sickest patients, and those in need of ICU care and ventilators. Avera also launched efforts to support and retain health care workforce, including such things as paying health insurance premiums, providing support payments, \$2 across-the-board pay increases, increased on-call pay and shift differentials, and more.

The primary service area is defined as Hutchinson County, South Dakota, including the communities of Freeman, Menno, Olivet and Tripp. Olivet is the county seat. According to the U.S. Census Bureau Quick Facts 2019 data, the estimated population of Hutchinson County as of July 1, 2019 is 7,291 and is predominately white at 96.2%. It is estimated that 22.9% of the population is 65 years and over. The median household income is \$57,089 with a 10.5% poverty rate. Uninsured individuals under age 65 is estimated at 12.3%.The secondary service area includes the coverage of 8 Hutterian Brethern Colonies and Charles Mix County. Charles Mix County is demographically different from the rest of the service area. The population is 32.7% Native American. The median household income is \$50,481 with a 21.2% poverty rate. Uninsured individuals under age 65 is estimated at 17.0%.
Part VI, Line 5:	The Organization's governing body is comprised of volunteer members who reside in the community. The Board of Directors meets monthly and has community representation that brings forward issues relative to challenges, needs and services within the community. The local ministerial group meets monthly at the Hospital and also identifies needs and gaps within the parishioners they serve. Medical staff privileges are extended to all qualified physicians in the community. The medical staff, including the physicians/mid-levels/department directors, has the opportunity to meet monthly and also discuss ways to meet the needs of the community they serve. Surplus funds are reinvested in facilities to improve patient care. The Hospital operates an emergency room that is available to all, regardless of ability to pay.ASBHC has a fitness center on campus that is available to help the community focus on wellness and prevention. This endeavor is subsidized by the facility to improve the health and well-being of the community as a whole. The chaplaincy mission services participate and spearhead many community projects including an angel tree at Christmas to address the needs of children in our service area. ASBHC also donates to the local food pantry and purchases, prepares, and serves a meal to the Love Feast in Mitchell, SD annually. The meal serves 300 plus people in need of nutrition. At that event, bags of groceries are provided to the families in need that are in attendance to take home. There are several other projects of this nature on a smaller scale at the local school system. ASBHC donates to community events such as American Cancer Society projects and sponsors health related educational programs to the community at large. Avera St. Benedict also provides medical, nursing, and other ancillary health professions the opportunity for hands on learning experiences through residencies, internships, clinical rotations and other shadowing and profession mentoring programs to help with students health care training needs.

Obesity Provided scheduled free access to Avera St. Benedict's Wellness Center and provided Fitness on Demand classes. The facility also continues to provide Meals on Wheel to the community. Transportation Facility has promoted telehealth services to reduce transportation needs and to keep residents safe during pandemic. In-home medical care has happened when able secondary to COVID, specifically in high risk populations. Deterioration of Homes* Collaboration with the Commercial Club and Economic Development started in hopes of launching a "paint a house" program. Due to COVID 19, further progress has been delayed. After School Activities for Kids Supported the public library in their efforts to have a safe after school program for kids. Due to COVID 19 there was minimal movement on this. Access to Care Worksite wellness screenings took place at three worksites with a social distancing method. The following health need needs were not addressed due to resource constraints for the hospital at this time: Walking/Bike paths Many areas of our implementation plan were not able to be completed due to COVID 19 and the continued surges and disease spread that we saw throughout the year. In order to keep the public health risk minimized, activities that would have potentially caused spread by putting people together in small places and putting staff at risk for contracting COVID 19 were not completed. The activities and priorities identified in the implementation plan will be addressed and implemented as able, secondary to COVID 19. Since many of our implementation plan efforts were collaborative, some of the other organizations either canceled programs or did not have the resources for some of the collaborative models because of the impact of COVID 19.
