On June 8, 2021, the Health Center and HHC Devon Real Estate, NFP executed a Debt Forgiveness Agreement with a tax credit investor (the Fund), to terminate the NMTC transaction. In conjunction with the agreement, the NMTC investors exercised a put option requiring HHC to acquire all membership interests in the Fund, resulting in HHC becoming the sole member of the fund. Furthermore, in connection with the Debt Forgiveness Agreement there was a defeasance of the \$7,840,000 of debt related to this transaction as well as the cancellation of the related \$4,721,600 note receivable resulting in a gain on termination of the NMTC transaction of \$3,077,899. Following the forgiveness of the debt and note receivable, the Fund was dissolved as of June 8, 2021.</p>
