Britepaths provides our neighbors in need with short-term safety-net services and empowers them to work toward long-term self-sufficiency.

Financial Empowerment Center (FEC) - Britepaths manages the FEC in partnership with Fairfax County government and the United Way of the National Capital Area. The FEC is a one-stop shop for financial coaching and related services. Clients work with a coach, who helps them create a step-by-step plan to achieve personal financial goals. The FEC also has budgeting classes, credit and banking classes, workshops on a variety of topics, pro bono legal assistance, assistance with taxes, small business development services, computer classes, and workforce development counseling. From March 16, 2020 to date, all services have been offered online. The FEC served 973 clients from January 1 to June 30, 2021.

4b (Code) (Expenses \$ 84,382. including grants of \$ 57,288.) (Revenue \$ 0.)

Food - Britepaths provides food assistance to its clients in four different ways: A) Emergency Support for families in immediate crisis, which provided food to 238 people in 76 households during the 6 months ended June 30, 2021, B) Food Bridge provides six to nine months of sustained food support while a client is concurrently enrolled in a mentoring program. Food Bridge served 182 people in 59 households during the six months ended June 30, 2021, C) Our Daily Veggies provides farmers' market vouchers of \$10 each in the summer months. During the six months ended June 30, 2021, Britepaths provided 575 vouchers to 519 people in 96 households, and D) Food4Thought provides supplemental food to students during weekends. 607 people in 15 schools were served during the six months ended June 30, 2021. In addition,

Financial Literacy - Britepaths offers financial education classes, workshops, one-on-one financial coaching and financial mentoring that Britepaths brings to various locations in the community. Mentored clients also have access to Matched Saving and no-interest Mpower Loans. The Financial Literacy program relies heavily on qualified volunteers to provide the services. Britepaths served 148 clients during January 1 to June 30, 2021.
