The Foundation has concluded that no provision for income tax is required in the Foundation's financial statements for the years ended June 30, 2021 and 2020. As of June 30, 2020, the Foundation had federal net operating losses available for carryforward in the amount of \$3,456,855 as a result of unrelated business taxable income ("UBTI") resulting from investments in the Trust. UBTI is taxed at the prevailing corporate tax rate. Reliance had a net operating loss carryforward of \$171,102 as of June 30, 2020. The loss carryforwards begin to expire in 2027. Due to the uncertainty about whether these losses will result in a tax asset, no tax asset is recorded in the financial statements. Net operating losses arising in tax years ending after December 31, 2017 have an indefinite carryforward period. Losses arising in earlier tax years have a carryforward period of twenty years. Losses arising in tax years beginning after December 31, 2017 are limited to 80% of taxable income in the year deducted. The filing deadline for the June 30, 2021 return is May 16, 2022. In addition to the fiscal year ended June 30, 2021, the years ended June 30, 2020, 2019, and 2018 are open for inspection by the taxing authorities.
