They do not receive refunds from their account, nor do they receive awards that exceed their charges. The majority of these fall into the following categories: Partnering programs - These students pay a portion (about 1/3) of the cost. Then receive discounts/scholarships for the rest. About half of these scholarships are funded by partnering organizations or donors, the other half are funded from the budget. We work closely with the partnering organizations to select qualifying students. Teach All Nations and Vision Scholars - These students have been selected as outstanding international students to receive up to 100% tuition discounts/scholarships. These students typically only pay the fees (some pay a portion of tuition). The majority of these awards are funded by restricted gifts. Our ultimate goal over the next 20 years is to have one scholarship recipient from every country in the world. Standard Institutional Aid - International students who enroll through our traditional programs qualify for many of the same awards that other students receive. These are mostly funded from our budget. Many of these students come to the U.S. on a student Visa and attend classes on the main campus.
