The Greenville-ENC Alliances staff shall be employees of the Greenville Utilities Commission and adhere to the personnel policies of the Greenville Utilities Commission. Staff shall receive employment benefits as set by the Greenville Utilities Commission including health insurance and retirement. Potential employees are recruited by the Greenville-ENC Alliance and salaries are established by the Organization. The Greenville-ENC Alliance, per the services agreement, shall reimburse the Greenville Utilities Commission monthly equal to the salaries, benefits, and other direct costs incurred for employees who actively work for the Greenville-ENC Alliance. Payroll expenses incurred to Greenville Utilities Commission was \$704,660 for the year ended June 30, 2021 which is included as salaries and wages, employee benefits, and payroll taxes on the schedule of functional expenses.
