WITH REDUCED HOURS AND LIMITED CAPACITY, WE WELCOMED VISITORS BACK WITH MULTIPLE SAFETY PRECAUTIONS IN PLACE. HAVING PIVOTED TO A ROBUST VIRTUAL PROGRAM IN SPRING 2020, THE CENTER COLLABORATED WITH PARTNERS, ARTISTS, SCHOLARS, AND ORGANIZATIONS ACROSS THE COUNTRY TO HOST OVER 90 VIRTUAL PROGRAMS AND ENGAGE OVER 3,546 INTERNATIONAL ATTENDEES. GIVEN THE LIMITATIONS ON IN-PERSON GATHERINGS, THE CENTER EXPANDED MARKETING EFFORTS TO ENGAGE A NATIONAL AUDIENCE WITH PLACE-BASED VIRTUAL PROGRAMS, SUCH AS VIRTUAL TOURS OF 7 EXHIBITIONS AND OTHER ONLINE PROGRAMS. ADDITIONALLY, WE LAUNCHED THE CENTER'S 25TH ANNIVERSARY. ACTIVITIES INCLUDED 25TH ANNIVERSARY BRAND DEVELOPMENT, A NATIONAL PRESS RELEASE DISTRIBUTION, A VIRTUAL CELEBRATION AND BENEFIT ATTENDED BY OVER 100 NATIONAL SUPPORTERS, AND THE LAUNCH OF A NEW NATIONAL MEMBERSHIP PROGRAM. WITH THE HELP OF GENEROUS FUNDERS AND DONORS, THE CENTER CONTINUES TO BUILD ITS ENDOWED FUNDS TO REMAIN A BEACON OF SUPPORT FOR THE MAKERS, SCHOLARS, AND CRAFT COMMUNITY.
