Advocacy- The Asheville Area Arts Council (Arts AVL) worked diligently to bring attention to the devastating impacts of COVID on the local arts sector, and the important economic contributions of the arts in Buncombe County. Buncombe County's 74 creative industries were responsible for over 14,000 jobs and \$1.6 B in industry sales in 2019, but the Arts & Entertainment industry experienced the greatest percentage of job loss of any industry in the County in 2020. Arts AVL conducted four impact surveys between March 2020 and January 2021, and published a 40+ page Creative Jobs Report in May 2021.

Form 990, Part III, Line 4b:

Public Art- The arts council was contracted by the City of Asheville to facilitate the installation a Black Lives Matter street mural in Pack Plaza in downtown Asheville. Arts AVL raised over \$16,000 for the project, and paid 19 artists for their work. The arts council also co-hosted an Equity in Creative Placemaking speaker series in partnership with Leadership Asheville as part of the Winter Buzz Breakfast series. This included national speakers, such as Former New Orleans Governor Mitch Landrieu, Monument Lab Co-Founder/Director Paul Farber, and Institute Professor at the Studio for Creativity, Place and Equitable Communities at Arizona State University Herberger Institute for Design & the Arts Maria R. Jackson.

Form 990, Part III, Line 4c:

Service for Creatives- The Asheville Area Arts Council awarded 65 grants and distributed \$286,780 through three grant programs in 2020-2021, including over \$251,000 in relief aid to 36 organizations through the NC CARES for the Arts grant. The North Carolina CARES for Arts grant is to offset business disruption and/or expenses incurred due to COVID-19 between March 1, 2020, and December 30, 2020. The 36 organizations that applied reported over \$4.2 million in eligible expenses, far exceeding the \$251,000 the arts council had to award. Of the 65 overall grants awarded, 22 or \$61,492 went to BIPOC led and/or focused organizations or initiatives. This is 21% of the funding awarded.
