THIS CENTER IS SET TO START CONSTRUCTION IN THE LATTER PART OF 2021 WITH A TARGET OPEN DATE OF JANUARY 2022.THE ERLANGER HEALTH SYSTEM UTILIZED FUNDS FROM THE COVID-19 RELIEF FUND TO PROVIDE A VARIETY OF NEEDED ITEMS AS IT RELATES THE CONTINUED CARE AND EXTRAORDINARY NEEDS RELATED TO SUPPLIES AND OTHER EXPENSES REQUIRED FOR THE ONGOING ISSUES WITH COVID. FUNDING FROM THE ALPER ENDOWMENT WAS GIVEN AS A SMALL FINANCIAL AWARD TO 50 DIFFERENT RESIDENTS FOR THEIR GREAT WORK OVER THE PAST YEAR. DONOR FUNDS WERE ALSO UTILIZED TO UPDATE AND REPLACE FURNITURE IN PATIENT ROOMS TO PROVIDE THE BEST AND MOST COMFORTABLE ENVIRONMENT FOR OUR PATIENTS AND FAMILIES DURING THEIR TREATMENT. GRANT FUNDING RECEIVED TO SPECIFICALLY SUPPORT THE CHILDREN'S HEALTHY EATING AND ACTIVE LIFESTYLE CLINIC. THESE FUNDS SUPPORTED STAFFING NEEDS, PROGRAMMATIC MATERIAL NEEDS AND SOME EXTERNAL PARTNERSHIPS SUCH AS WALKING TRACKS AT LOCAL SCHOOLS PARTICIPATING IN OUR COMMUNITY EXTENSION OF THIS PROGRAM. ERLANGER WESTERN CAROLINA HOSPITAL CONTINUES TO RECEIVE SUPPORT FROM THE REGION WHILE PROVIDING TOP-NOTCH CARE IN AN AREA THAT WOULD HAVE BEEN WITHOUT A HOSPITAL WERE IT NOT FOR ERLANGER'S INVOLVEMENT. OTHER WAYS WE UTILIZED DONATED FUNDS INCLUDED PURCHASING UPDATED PATIENT MONITORS FOR THE PEDIATRIC INTENSIVE CARE UNIT, PROVIDING CAR SEATS FOR NEW PARENTS WHO REQUIRED THEM, UPDATING A RESIDENT AND FELLOW CONFERENCE ROOM, AND THE PROVISION OF ARTWORK TO ENHANCE SEVERAL AREAS OF OUR HEALTH SYSTEM.
