Established in 1974, Daily Living Centers is Oklahoma's first and leading adult day provider for senior adults and adults with disabilities ages 18 and older. Our mission is to be Oklahoma's leader in quality, affordable adult day health services and independent living services delivered with dignity. We offer non-residential affordable day services in an environment that enhances mind, body, and spirit. While attending Daily Living Centers our "participants" enjoy healthy meals, exercise programs, socialization, art and music therapy, activities, and games. We are professionally staffed with LPN's and nurse aids to provide health care monitoring and assistance with activities of daily living. Statement continued on Schedule O. Our services keep our participants healthy, independent longer and thriving at home while reducing isolation. We hear often that our services are "life-saving." They not only benefit the participant but their caregiver as well by giving them peace of mind and hope, the ability to continue to work, and rest from 24/7 caregiver duties. A new participant was recently asked by their caregiver about their first day at Daily Living Centers the participant, described their experience to be like a warm hug." Daily Living Centers serves the Oklahoma City Metro area with four locations in Bethany, Edmond, South, and Northeast Oklahoma City. We are open 246 days a year and serve on average 92 participants daily. In FY21, Daily Living Centers underwent 67 days of closures due to COVID-19 and inclement weather in efforts to protect our caregivers, participants, and staff. We provided 68,000 healthy meals including breakfast, lunch, and snacks and over 30,000 transportation trips. We are one of the only adult day healthcare providers that offer door-to-door transportation, med rides, and outings that promote community interaction and provide educational opportunities. Of those we serve, 80% would not be able to attend our adult day centers without transportation, and often the caregivers do not have the financial means to pay for transportation services. To meet the need of the community we nearly doubled our fleet from 14 to 24 vehicles including limos, sedans, and wheelchair accessible vans. With this addition to our fleet, we expanded our services and partnered with EMBARK to provide free med rides for seniors 65 and older that desperately need transportation to their doctor and pharmacy. Each year, we provide over \$500,000 in adult day services scholarships and over \$300,000 in transportation scholarships. Services through Daily Living Centers are more affordable than all other long-term care options and saves the state money. Our sustainability is funding through DHS, VA, Advantage Waiver, DDS, and private pay. Our scholarship programs are funded through the on-going support from generous community donors. Our goal is to never turn anyone away due to financial need.
