The Library Foundation, through private contributions, supports enriched programs, services, and resources, as well as public-access technology and collections enhancements for its main (Jackson, WY) and branch (Alta, WY) library. Foundation-funded programs include - but are not limited to - Tax Prep Assistance, Born-to-Read, Latino Outreach, Page to Podium Author Visits, ACT Test Prep, and Summer Reading. In addition, the Library Foundation has historically purchased equipment such as computers (including desktop, laptop, and tablet models), printers, projectors, display monitors, wi-fi hotspots, and gaming consoles. The Foundation also funds a Housing Assistance Program for library staff to help address the significant cost of rental and ownership housing in Teton County.
