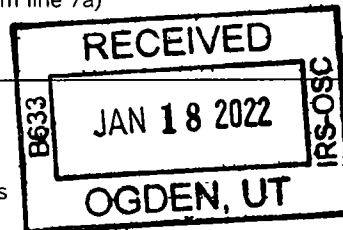

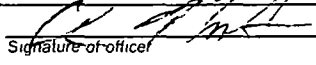
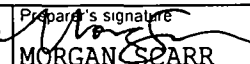

THIS ALSO INCLUDES SCHEDULED APPOINTMENTS FOR ALL HOMELESS VETERANS AND VETERANS THAT ARE STUDENTS THAT NEED RIDES TO A SCHEDULED VA APPOINTMENT. THE FUNDS FOR THE VANS ARE ALL RAISED BY DONATIONS. THEN WHEN PURCHASED, THEY ARE TURNED OVER TO THE VA WHO MAINTAINS THEM AND PAYS FOR ALL FUEL. IN RETURN, THE VA ALLOWS THE DAV TO MANAGE THE DAV VOLUNTEER TRANSPORTATION NETWORK WITH OUR ENTIRE VOLUNTEER STAFF AND OUR TWO PAID HOSPITAL SERVICE COORDINATORS (HSCS) EACH OF WHICH MANAGES TEN LOCAL AREA COORDINATORS (LACS) AND CLOSE TO 250 VOLUNTEER DRIVERS IN DIFFERENT AREAS THROUGHOUT MONTANA. THE DAV IS HELPING ALL VETERANS AND CONTINUES TO GROW.

THE DAV DEPARTMENT OF MONTANA HAS 5,500 REGISTERED MEMBERS WHICH REPRESENT THE 36,000 DISABLED VETERANS HERE IN MONTANA BUT WE SERVICE ALL 108,000 MONTANA VETERANS. THE DEPARTMENT HAS NINE CHAPTERS AND THEY FOLLOW THE SAME STRUCTURE AND GUIDELINES AS THE DEPARTMENT AND NATIONAL ORGANIZATION.
