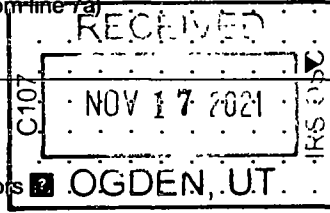

PROGRAM ACCOMPLISHMENTS

With in-person filming postponed during the 2020-21 year, Look What SHE Did! focused on moving all existing footage through the post-production process, effectively completing work on more than 25 films that had been shot in years prior. During this one-year period we premiered 15 new films, and our original films were viewed more than 100,000 times on the Look What SHE Did! website, social media channels, and other video platforms

A series of virtual film screening events was launched in 2020, with six unique events being presented during the year. Five of those events were presented for free viewing in partnership with various community organizations. Our Women's History Month virtual fundraising event featured labor activist Dolores Huerta in conversation with Look What SHE Did! filmmakers
