The program continued to grow both financially and programatically this year. We moved to a virtual format during the Covid-19

Pandemic, and in this way, we were able to engage all 28 of our students in virtual versions of our interactive career-readiness

workshops throughout the year. In addition, we again provided summer internships to all of our rising seniors. Half of these internships

were virtual, at area hospitals and universities. The other half of the internships were in person at the police department and local auto

shops. Most of our Mentoring Program this year was virtual. The mentors and the students did a great job keeping up a meaningful

connection via Zoom. In this way, the students built relationships with professionals in the community. During the tax year in question,

we also added additional one-on-one virtual coaching sessions for our participants to support them as they researched and planned for

their post-high school future. We used these sessions to reinforce and practice soft skills and career-prep tools, such as: communicating

with a boss and coworker, practicing for job interviews, creating a resume and personal budget, applying for scholarships and much more.

This additional support had a meaningful impact and enabled students to achieve our program objectives.
