THUS, THE FOUNDATION IS A TOOL THROUGH WHICH PRIVATE SUPPORT IS RAISED AND MANAGED FOR THE SOLE BENEFIT OF EWU. OVERSEEN BY A BOARD OF DIRECTORS AND STAFFED BY A PROFESSIONAL DEVELOPMENT TEAM WHO ARE UNIVERSITY EMPLOYEES, THE FOUNDATION ADMINISTERS ALL GIFTS IN A BUSINESS-LIKE MANNER IN ACCORDANCE WITH THE DONOR'S WISHES. WHEN GIFTS ARE RECEIVED BY EWU COLLEGES OR OPERATING UNITS, THEY ARE FORWARDED FOR GIFT PROCESSING AND OFFICIAL ACCEPTANCE AND ACKNOWLEDGEMENT BY THE FOUNDATION.
