The terms of the sale are all cash in the amount of \$4,000,000 and includes all real property and limited personal property. The sale is anticipated to close in March of 2022, with the resulting gain on the sale to be reported in the fiscal year ending June 30, 2022. On March 17, 2021, the Organization and the City of Bakersfield entered into an Agreement to transfer ownership of the Organization's Material Recovery Facility. Terms of the sale were all cash in the amount of \$3,000,000 and included all real and personal property related to the recycling operations. The sale was completed on July 20, 2021, with the resulting loss on the sale to be reported in the fiscal year ending June 30, 2022.</p>
