Hand in Hand initiated its resource center, providing bilingual and multicultural curriculum and teacher training to 12 preschool classes outside of the Hand in Hand network, in collaboration with municipal education departments. Hand in Hands schools and communities led rallies and programs across Israel to call for non-violence and dialogue during the May 2021 Jewish-Arab unrest and conflict. During the Covid pandemic, Hand in Hand conducted approximately 15 Zoom calls with hundreds of participants around the world.
