Otis Health Care Center, Grace Cottage Foundation, or any affiliates of either. 3. The CEO of the sole member, Carlos G. Otis Health Care Center, and the Executive Director of Grace Cottage Foundation shall be ex-officio members of the Board of Directors. These ex-officio members shall not hold office or have voting rights. In addition, one member of the Board of Trustees of Carlos G. Otis Health Care Center shall serve as an ex-officio member of the Board of Directors. This person shall not hold office, but shall be entitled to vote. 4. The Board of Directors of the Foundation shall consist of up to fifteen (15) Directors and not less than seven (7) Directors, who shall be nominated by current Board members of the Foundation and elected by the sole member. Directors will be elected to a term of three (3) years (renewable twice) for a maximum of 9 years. The previous bylaws authorized up to twenty (20) Directors with no minimum number of Directors. The previous bylaws allowed Directors to serve one (1) year terms that were renewable without limit. 5. An Investment Committee shall be formed, chaired by the Treasurer. The Investment Committee shall include the Treasurer of the sole member and the CFO of Carlos G. Otis Health Care Center.
