IN ADDITION TO SUBSIDIZING FOOD FOR THE POOR, AMERICAN FRIENDS OF YAD ELIEZER SPONSORS JOB TRAINING AND ADOLESCENT MENTORING PROGRAMS THAT ASSIST NEEDY FAMILIES AND GUIDE THEM TOWARD ECONOMIC RECOVERY AND ENHANCED SOCIAL DEVELOPMENT.ADDITIONALLY, YAD ELIEZER PROVIDES CASH DISBURSEMENTS TO THOUSANDS OF FAMILIES FOR A ONE-TIME NEED. WHETHER DUE TO A MEDICAL EMERGENCY, AN UNEXPECTED EXPENSE, OR THE NEED TO GET THROUGH A DIFFICULT TIME, THIS FUND ALLEVIATES THEIR FINANCIAL DISTRESS AND ALLOWS THEM TO FOCUS ON REAL ISSUES. THESE GRANTS OFTEN PREVENT A ONE-TIME CRISIS FROM FORCING A FAMILY INTO A DOWNWARD SPIRAL OF POVERTY FROM WHICH THEY CAN NEVER ESCAPE.
