In Fiscal Year 2020, we purchased a building in Puerto Rico for establishing a Vedanta house of worship, for \$126,377. This is not listed as an "expense" since the building is now owned by us. We also began the purchase of a building in Seymour CT, investing \$38,300 in FY 2020. The purchase was completed at the beginning of FY 2021. In FY 2020 we also offered an interest-free loan of \$70,000 to the Vedanta Center of Greater Houston, towards the purchase of a retreat property.
