The following compensation philosophy was adopted: to compensate employees fairly and equitably based on external market data and internal value. The consultant developed new salary structures, reviewed each position based on an external market value and internal parity to develop recommended grading. The consultant then worked with the Executive Team to develop updated compensation procedures. Two compensation committees were established. The Management Committee of the Board of Directors will recommend to the Board all salary grade changes, job description changes and/or new job descriptions developed for the CEO and for all employees reporting directly to the CEO. The Operations Compensation Committee is comprised of the agency's CEO and the Vice President of Human Resources, Vice President of Operations and Vice President of Finance. The committee will approve any changes to the existing Compensation Procedure, all promotions and/or salary grade changes for existing positions as well as grading for any newly created positions. The Agency's Salary Structure was approved by the Board of Directors in the prior fiscal year and was left the same for the current fiscal year.
