SkillUp; SkillUp is a program that provides Food Stamp and TANF recipients opportunities to gain skills, training or experience that will improve their ability to attain employment and decrease their dependency on public assistance programs. The intention of the program is rapid attachment to work that leads to self-sufficiency for families. The program offers job search, training, education and supportive services to participants. MCAN provides T/TA to sub-contractors, as well as program monitoring. SkillUp is a voluntary program for all food stamp and TANF recipients.

Poverty Simulations: Community Action Poverty Simulation (CAPS) promotes a greater understanding of poverty. During the simulation, participants role-play the lives low-income families from single parents trying to care for their children to senior citizens trying to maintain their self-sufficiency on Social Security.

MCAN Membership Program: MCAN is the membership association for Missouri's Community Action staff and agencies. Per the member agreement, member dues are voluntarily collected by the agencies and sent to MCAN. These dues are determined by the MCAN Board of Directors and support MCAN's mission of advocating for those in poverty and educating the public about its effects. More than 1,000 Community Action staff and 18 agencies are currently members of MCAN and actively engage with the association's advocacy and education efforts. MCAN has served as the collective voice for those in poverty and Missouri's Community Action network since 1971.
