TEFAP and similarly controlled food distribution is monitored in accordance with donating agency policy with required reports submitted to those agencies. Though we do not account for the cost of food or supplies donated to us, these donations are logged. For kitchen meals and groceries, our client assistance is significantly augmented by community and agency food donations - individuals, business/faith/school/community groups, US Post Office, Boy Scouts, etc. The costs in columns (c) and (d) represent Fish's actual cash expenditures in support of the particular form of assistance. In the case of utility, prescription, and transportation assistance, the cash payments are made to the client's service provider and not to the client. We minimize the risk of clients "double dipping" by coordinating assistance with other community organizations. Kitchen meals are served daily on site and provided to all who come. The counts are based on sign-in logs, occasionally estimated. Groceries assistance is provided to a family/single no more than once a month - 3 full bags. Utility assistance is provided no more than once a year and pharmacy assistance as needed. In addition, Fish provides Christmas in July, Thanksgiving, and Christmas baskets, providing a holiday meal for a family/single. Counts are based on logs.
