All applications are reviewed by the senior staff of the Foundation, who ensure that awarded grants meet all criteria for need and strategic relevance. Once a grant is awarded, usage and outcome reports are generally required. In a few cases, grantees are required to present findings from educational opportunities funded through grants. Emergency grants are also available through separate funds for employees and patients. In these cases, the applying individual will fill out a standardized form, which includes need and support documentation, which is then submitted to the Foundation and reviewed weekly by committees comprised of employees representing departments throughout Carilion Clinic.
