THE FOUNDATION BEGAN OPERATION IN 2001 AND HAS AWARDED GRANTS AND LEADERSHIP AWARDS IN THREE FOCUS AREAS - CULTURAL PRESERVATION, ECONOMIC DEVELOPMENT AND EMPLOYMENT OPPORTUNITIES. CULTURAL PRESERVATION*CHEROKEE LANGUAGE INITIATIVE:ONE OF THE MOST RECOGNIZABLE CULTURAL PRESERVATION INITIATIVES IS THE CHEROKEE LANGUAGE REVITALIZATION INITIATIVE, WHICH IS A MOVEMENT TO SAVE THE CHEROKEE LANGUAGE. THE FOUNDATION SUPPORTED THIS IN 2021 BY GRANTING MORE THAN \$50,000 TO WESTERN CAROLINA UNIVERSITY FOR ITS CHEROKEE LANGUAGE PROGRAM. THE FOUNDATION SUPPORTED SNOWBIRD CHEROKEE TRADITIONS WITH MORE THAN \$37,000 TO SUPPORT CHEROKEE SECOND-LANGUAGE LEARNERS. LEADERSHIP AND CIVIC PARTICIPATION:*TIMES OF CHANGE ARE TIMES OF OPPORTUNITY, BUT ONLY IF WE ARE SECURE IN OUR IDENTITY AND LEADERSHIP SKILLS. THE EMERGENCE OF A SOLID LEADERSHIP BASE IS ESSENTIAL IN MAINTAINING A SUSTAINABLE COMMUNITY.
