The contracted missionaries served in Europe, Italy, Alaska, Mexico, and the United States where they performed a variety of activities, including evangelism, church planting and support, practical community help and relief, training, and discipleship etc. In this grouping the annual amount of monthly support payments was \$240,802.37. Bethany Fellowship, a US non-profit organization had missionaries that served in Asia, Ghana, Mexico, Republic of Georgia. Field of Wheats has a husband-and-wife team that served in Israel.
