In addition to the performance stages, there are several themed festival areas: the Montana Folklife Area, the Family Area, two Festival Marketplaces and the Festival Food Courts. Admission throughout the three-day festival is free for everyone. The festival attracts an estimated 170,000 visitors annually to Butte, Montana's National Historic Landmark District. During 2020 and 2021, Mainstreet Uptown Butte, Inc. was unable to hold the Montana Folk festival due to the COVID-19 pandemic. Various program expenses continued to be incurred during that time in an effort to sustain the festival so that it will continue in 2022.
