THE MUSEUM MAKES A SPECIAL EFFORT TO ACCOMMODATE SCHOOLS AND STUDENTS WHO WOULD OTHERWISE BE UNABLE TO ENJOY THE CURIODYSSEY PROGRAMS. VOLUNTEERS ARE AN ESSENTIAL PART OF CURIODYSSEY AND CONTRIBUTED OVER 7,774 HOURS IN THE PERIOD ACROSS THE ORGANIZATION - WILDLIFE, EDUCATION, OUTREACH AND ADMINISTRATION. CAPITAL PROGRAMS - DECEMBER 2020 SAW THE KICKOFF OF CURIODYSSEY'S FIRST CAPITAL PROJECT UNDER THE NEW MASTER PLAN.
