It is now providing local primary health care services staffed with a clinical officer lab tech pharmacist and security personnel. Visiting eye and dental clinics are held regularly. We also contribute to Friends of Dago which provides elementary and preschool education services in Dago Kenya.

It has also been equipped to provide primary and obstetrical care and minor surgery including cataract surgery and dental procedures. It has been certified by the Kenyan government and within the last 2 months it has been staffed by a Kenyan Clinical Officer - equivalent to a Nurse Practitioner. Ophthalmology clinics are held there twice a month and a dentist is there 3 times a month. While it is too early to have good estimates of numbers in past years clinics held by visiting medical teams have seen over 800 patients over 3 days.
