Grant distributions will generally be paid to Internal Revenue Code Section 501(c)(3) organizations for charitable or educational purposes. Priority will be given to those organizations which have demonstrated active efforts to help themselves, either through substantial volunteer support or broad-based fundraising, and which exhibit the following characteristics:

- Active board leadership and community involvement;
- A comprehensive strategic plan for resource development, funds acquisition and development, and resource-sharing with other non-profit groups; and
- Efficient and effective administration of programs and funding.

Grant requests will be actively solicited through various media and through word-of-mouth, and will be considered either upon receipt or on a quarterly basis, depending on the amount requested. Grant requests must be in writing, and should include the following information:

- A brief description of the organization;
- The service area and beneficiaries of the organization's charitable efforts;
- A copy of the organization's Internal Revenue Service determination letter as to status under Internal Revenue Code Section 501(c)(3) and non-private foundation status under Section 509(a);
- A brief statement of the need to be addressed;
- The specific purpose and amount of the request, and an itemized budget for the project; and
- Criteria for evaluating the results of the project.

Grants are geographically limited to organizations within the United States, though strong preference will be given to organizations serving the needs of southwestern Pennsylvania. Support generally will not be granted to fraternal organizations; conferences or seminar attendance; specialized health campaigns; or national organizations. No support will be granted for private foundations as defined under Internal Revenue Code Section 509(a); loans or direct grants to individuals; or political campaigns, parties, or candidates.

The Organization awards scholarships as described in IRC Section 4945(g)(1) and/or fellowship grants described in IRC Section 117(a), awarded on an objective and nondiscriminatory basis, and used for study at an educational organization described in IRC Section 170(b)(1)(a)(ii).

The scholarships awarded are based on an intricate screening process based on the applications received. Basic requirements include that the student or an immediate family member must be a Washington Financial customer for at least 1 year, and the student must have at least 100 hours of community service during the 12-months preceding the month of application. Selection is based on a

scoring system, which considers community service, class standing, and financial need. It is renewable up to a maximum of four years and the student must retain full-time status and a passing grade point average. Verification must be sent annually.
